II. <u>KIPP DC</u>

KIPP DC is a network of high performing public charter schools whose mission is to create and sustain the highest quality college preparatory school system for the most underserved communities in Washington, D.C. KIPP DC students develop the knowledge, skills, and character necessary to become thoughtful, influential and successful citizens in the competitive world. KIPP, generally hailed as the country's most successful experiment in educating low-income minority youths, came to the District in 2001 when KIPP DC: KEY Academy opened in a church basement in Anacostia with a group of 80 5th graders.

KIPP DC currently consists of sixteen schools located across the District at six campuses, and is serving over 5800 students. Over the next few years, KIPP DC will grow to serve over 6,000 students at its current campuses.

Scope of Work:

It is the intention of KIPP DC to engage the services of a contractor to support our robust special education services for an indeterminate number of students and evaluations for the following services:

- Comply with all Federal and State Special Education Law/requirements
- Occupational Therapy (if needed)
- Vision services
- Physical therapy
- Audiology Service
- Assistive Technology
- Evaluations (as needed) including but not limited to Physical Therapy Evaluation, assistive technology evaluation Auditory Processing Evaluation
- Homebound/tutoring instruction
- Translation Services (including translation services for sign language)

Responses should be based on the ability to provide services as needed as well as the following criteria:

- Utilize a variety of research-based intervention strategies, continually assessing the students response to intervention and make modifications as needed to ensure all children are successful,
- Work collaboratively with school based staff.
- Provide evidence of individual's licensure including background checks
- Providers should be familiar with SEDS data base and be able to update IEP goals and present levels of performance.
- Provide itemized record of services rendered
- Provider should perform discharge summaries for students no longer qualifying
- Providers should be willing and able to complete all paperwork related to Medicaid
- Providers will work with compliance manager to schedule students.
- Proposal should outline all costs including services and cost per evaluation
